WITNESIDES and JENNIFER WHITESIDES (the "Whitesides") and Defendants, MHI
PARTNERSHIP, LTD. d/b/a PLANTATION HOMES and MCGUYER HOMEBUILDERS, INC.
(collectively, "MHI"), by and through their respective attorneys of record, who announced to the
Court that the parties have agreed to submit the claims and/or causes of action to binding arbitration.
It is, therefore,

ORDERED that the above-styled and numbered cause is stayed and Plaintiffs shall submit
the claims and causes of action against MHI made the basis of this lawsuit to binding arbitration. It
is further

ORDERED that James M. Stanton and Kyle Gooch are hereby appointed to act as arbitrators
of this cause of action. It is further

ORDERED that Mr. Stanton and Mr. Kyle Gooch shall choose a third arbitrator for a total
arbitration panel of three (3) neutral arbitrators. It is further

ORDERED that MHI shall pay one-half (1/2) of the arbitrator's fees for James M. Stanton and
all of the arbitrator's fees for Kyle Gooch and for the third arbitrator and that the Whitesides shall

pay the other one-half (1/2) of James M. Stanton's arbitrator's fees.




